### THE GREAT FOOD FESTIVAL 2018 1-DAY ACCESS PASS TERMS & CONDITIONS

The GREAT Food Festival (“TGFF”) 1-Day Access Pass includes:

- a. One Wristband Redemption Voucher for Admission into TGFF
  - b. One Complimentary Dish from Star Chef Arena
  - c. One Complimentary RWS Invites Membership
1. The redemption of RWS Invites Membership is only available for new sign-ups from now till 14 October 2018.
  2. The TGFF 1-Day Access Pass is valid for use only on a specific The GREAT Food Festival Event Date selected by guest (“TGFF Event Date”).
  3. Exchange for TGFF 1-Day Access Pass Wristband is to be made at designated TGFF Ticketing Counters during the operating hours of the same.
  4. Verification checks may be done at the time of collection.
  5. Request of change of TGFF Event Date will not be entertained once selection is made.
  6. By purchasing TGFF 1-Day Access Pass, the guest shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and any other instructions, terms and conditions that Resorts World at Sentosa Pte Ltd (“RWS”) may issue from time to time.
  7. The TGFF 1-Day Access Pass sold is not exchangeable for cash or any other products or services and cannot be used in conjunction with any promotions, discounts and privileges.
  8. The TGFF 1-Day Access Pass is neither replaceable nor refundable whether in whole or in part, and shall also not be used for any form of promotional uses unless approved in writing by RWS.
  9. RWS shall not be liable to any persons purchasing this TGFF 1-Day Access Pass for any injuries, losses or damages in respect of, in connection with and/or arising from the TGFF 1-Day Access Pass promotion.
  10. A guest shall fully indemnify and hold RWS harmless from and against any loss, damage, cost, liability or expense (including legal fees), whether direct or indirect, which RWS incurs in respect of, in connection with and/or arising from the guest’s breach of these Terms and Conditions.
  11. RWS reserves the right to withdraw or cancel the TGFF 1-Day Access Pass and to amend or change these Terms and Conditions at any time for whatever reason and without giving prior notice. The decision of RWS on all matters relating to or in connection with the TGFF 1-Day Access is final, and no correspondence will be entertained.

12. The Terms and Conditions of this TGFF 1-Day Access Pass shall be governed by and interpreted in accordance with Singapore law. The Courts of Singapore shall have exclusive jurisdiction over any disputes arising from these Terms and Conditions, including the validity and enforceability thereof.
13. In the event of inconsistency or discrepancy between the English version and the other versions of these Terms and Conditions, the English version shall prevail.
14. In the event of inconsistencies or discrepancies between these Terms and Conditions and the contents of any brochure, marketing and/or promotional materials relating to the TGFF 1-Day Access Pass, these Terms and Conditions shall prevail.
