THE GREAT FOOD FESTIVAL 2018 EVENT TERMS & CONDITIONS

Entry to The GREAT Food Festival Event (the “Event”)

1. Resorts World at Sentosa Pte Ltd (“**RWS**”) reserves the right to (i) take possession of the ticket of; or (ii) refuse entry to any person who:
 - a. cannot produce a valid ticket;
 - b. presents a ticket that has not been purchased from RWS or other authorised points of sale;
 - c. presents a ticket that is defaced or becomes illegible, or if it is reasonably suspected that the ticket is a stolen ticket or is a counterfeit; or
 - d. breaches or is attempting to breach any of these terms and conditions.
2. In addition to the above, RWS also reserves the right, at all times and in its sole discretion, to refuse entry or remove any person(s) as it deems necessary (including without limitation any person(s) whose conduct is disorderly or inappropriate or who poses a threat to security or to the enjoyment of the Event by others). No refund or compensation will be made to such person(s).
3. RWS reserves the right to take possession of prohibited or dangerous items, and refuse entry or remove any persons possessing such items.
4. Ticket holders may be subject to search of their possessions (including bags and clothes), for safety reasons.
5. No outside food or beverages are permitted at the Event.

General Ticketing

6. Tickets sold are not refundable, not exchangeable, not transferable and not for resale.
7. Please keep the ticket in good condition as a replacement ticket will not be issued if the original ticket is lost, stolen, altered, tempered, defaced, or becomes illegible.

Others

8. RWS may, at any time, without notice and without refund or compensation or any liability, relocate the Event, change, restrict admission to or stop the Event in the event of unforeseen circumstances.
9. Tickets are not to be used for any form of promotional uses unless approved in writing by RWS.

10. Food Allergy Warning: Please be advised that that the menu items at the Event may contain allergens or may have come into contact with allergens like nuts, milk, eggs, soy, wheat, and others. RWS is unable to make special accommodation and there can be no assurance that any food is allergen-free. It is your responsibility to take reasonable precautions of any food allergies or food intolerances.
11. RWS shall not be liable for any loss, injury, claim, liability or damage resulting in any way from fire, steam, electricity, gas, water, or rain, or from the breakage, leakage, obstruction, or other defects or pipes, sprinklers, wires, appliances, plumbing, air conditioning, or lighting fixtures, or from theft, vandalism, earthquake, act of God, or from any other cause.
12. By participating in the Event, the guests shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and any other instructions, terms and conditions that RWS may issue from time to time.
13. RWS shall not be liable to any persons in the Event for any injuries, losses or damages in respect of, in connection with and/or arising from the Event.
14. RWS reserves the right to video, photograph, and/or record the Event, and publish any guest's images and details for the purposes relating to the publicity of the Event without having to pay any fee or compensation to the guests.
15. RWS reserves the right to withdraw or cancel the Event and to amend or change these Terms and Conditions at any time for whatever reason and without giving prior notice to the guests. The decision of RWS on all matters relating to or in connection with the Event is final, and no correspondence will be entertained.
16. A guest shall fully indemnify and hold RWS harmless from and against any loss, damage, cost, liability or expense (including legal fees), whether direct or indirect, which RWS incurs in respect of, in connection with and/or arising from the guest's breach of these Terms and Conditions.
17. In the event of any inconsistencies of discrepancies between the Terms and Conditions and the contents of any brochure, marketing and/or promotional materials relating to the Event, these Terms and Conditions shall prevail.
18. A person who is not a party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any of these Terms and Conditions.
19. In the event of inconsistency or discrepancy between the English version and the other versions of the Terms and Conditions, the English version shall prevail.
20. The Terms and Conditions of the Event shall be governed by and interpreted in accordance with Singapore law. The Courts of Singapore shall have exclusive jurisdiction over any disputes arising from these Terms and Conditions, including the validity and enforceability thereof.
