### THE GREAT FOOD FESTIVAL 2018 SQUAD BUNDLE 4-DAY ACCESS PASS TERMS & CONDITIONS

The GREAT Food Festival (“TGFF”) Squad Bundle 4-Day Access Pass includes:

- a. Four Wristband Redemption Vouchers for Admission into TGFF
  - b. Four Complimentary Dish Redemption Vouchers from Star Chef Arena
  - c. Four Complimentary RWS Invites Membership
1. The redemption of RWS Invites Membership is only available for new sign-ups from now till 14 October 2018.
  2. The TGFF Squad Bundle is valid for use to enter the Event throughout the full event period.
  3. Each Wristband Redemption voucher admits one (1) guest to the event.
  4. Exchange for TGFF Squad Bundle 4-Day Access Pass Wristband and Complimentary Dish Voucher is to be made at designated TGFF Ticketing Counters during the operating hours of the same, upon presentation of the Wristband Redemption Voucher and Complimentary Dish Redemption Voucher.
  5. Complimentary Dish can only be redeemed from any restaurant at Star Chef Arena.
  6. The Complimentary Dish voucher is valid for one time redemption on any Event date at the Star Chef Arena.
  7. Verification checks may be done at the time of collection.

14. The Terms and Conditions of this TGFF Squad Bundle 4-Day Access Pass shall be governed by and interpreted in accordance with Singapore law. The Courts of Singapore shall have exclusive jurisdiction over any disputes arising from these Terms and Conditions, including the validity and enforceability thereof.
15. In the event of inconsistency or discrepancy between the English version and the other versions of these Terms and Conditions, the English version shall prevail.
16. In the event of inconsistencies or discrepancies between these Terms and Conditions and the contents of any brochure, marketing and/or promotional materials relating to the TGFF Squad Bundle 4-Day Access Pass, these Terms and Conditions shall prevail.
